The optimized assessment of size of a series of garments in the context of the production cycle duration

This article considers the problem of computing the number of decks on a series of garments that provide optimal balance between the duration of the production cycle and the volume of work in progress.

Factors are analyzed impacting on the efficiency of the production process. The structure of financial costs and time spent on different stages of the production cycle in the preparatory-cutting and garment production, depending on the size of the series is examined. The method of assessing the magnitude of the series, based on the balance of the duration of the production cycle and the volume of work in progress with the efficiency criterion providing the minimization of costs per unit of production is proposed.

A mathematical model of optimization of the number of decks is given, taking into account the completeness of the classifications and the number of cloths in the flooring on a series of garments. The method of calculating optimized estimates of the number of decks is developed, which is an integer variable. Numerical calculations are presented.
