Monitoring of tax revenues and registration of participants of investment projects in the Sakha (Yakutia) Republic

The article shows the results of work of tax authorities of the monitoring of tax revenues from the organizations involved in the implementation of large-scale investment projects in the Sakha (Yakutia) Republic which carried out the control of tax base and statement on tax accounting of these structures and their separate divisions. Effective monitoring is allowed in the period from 2009 to 2016 to ensure substantial growth of revenue in the budget of the Republic at the expense of income taxes on the income of individuals and property organizations. The special attention was paid to the timely registration of separate divisions of those taxpayers which headquarters are outside of the republic. Different sources of information were used for this purpose. This has made it possible to register more than 70 separate divisions in addition and to provide an annual gain of the taxes for the regional budget of 3% to the total amount of tax revenues.

To gain control was proposed to introduce quarterly statistical form of the departmental tax reporting on the number of separate subdivisions of the out-of-town structures operating at the territory of the subject of Federation.
