Organizational and institutional forms of implementation of transport-transit potential of Russia on a basis of state-private partnership. Part I.

This article reviews the theory and practice of application of public-private partnership (PPP) mechanism within implementation of investment projects aimed at development of the transport and transit potential of Russia. It demonstrates that PPP should be considered broadly as the utmost possible way of interaction between the public and private sectors aimed at increasing value added ensured within the country, and infrastructural tool to ensure increased export of transport services. The article reveals, systemizes and analyzes major internal and external unfavorable factors impacting on the volume of transit cargo transportation throughout Russia. It particularly describes the complex impact on implementation of transport and transit potential of the country, implementation of the China People's Republic's Project on Silk Road Economic Belt, independent policy of the Eurasian Economic Union's (EAEU) member states — Belarus, Kazakhstan, Armenia and Kyrgyz Republic in the area of construction of transport infrastructure and arrangement of transboundary transportation, consequences of transit conflicts with neighboring countries and EU countries. The article reviews main active projects on development of transport and transit system of Russia with application of PPP mechanism: establishment of Moscow-Kazan high-speed network with its further extension to the Chinese border, construction of transport and logistics facilities in Chelyabinsk and Kaluga provinces, ensuring infrastructure for transit cargo transportation via the Northern sea route, participation of foreign investors in development of Russian seaports and approaches to them. It proves that development and implementation of Russia's transport and transit potential, improving competitiveness of the Russian carriers at the global transport services markets requires establishing large-scale transport and transit

companies, merging and enlarging existing enterprises. However, as the experience of establishment of Unified transport and logistics companies (UTLC) showed, contradictions between the founders, EAEU participating states' individual programs on development of their transport and transit potential prevents implementing competitive advantages of this integration project to the full extent. With this regard, the article focuses on identification of opportunities and necessity of administrative transformations associated with the establishment of a large public-private transport company capable of competing with the global maritime container services in the route of Asia-Europe. It develops main areas and activities within the proposed national project of "Development of Transit Economy of Russia: connecting Eurasia" and its subprogram "Establishment of Innovative Rolling Stock for Container and Mixed Transportation". This article is the first part of the study. The second and third parts will be published in the magazines «Today and tomorrow of the Russian economy» and «Scientific Review. Series1. Economics and Law» in 2016.
